\*/ Thirteen males and one female inmate in this issue appear with a plus sign (+) next to their names. Seven of them (4B, 3W) are under death sentence in two states, two (1W, 1B) are under death sentence in three states, and the others (2B, 3W, 1N) are serving term sentences previously imposed in other states. All multiple death-sentenced inmates are listed in their respective several state totals, but each is counted as only one inmate in the national total.

This issue of Death Row, U.S.A. includes bracketed names for 117 capital inmates. The brackets indicate that either a new sentence proceeding is pending following a court order, or that a court-ordered reversal of conviction or sentence is not yet final due to an appeal filed by the State.

Thirty-four males and two female inmates in this issue appear with a (#) sign next to their names. These inmates were all under the age of eighteen at the time of offense.

UNITED STATES SUPREME COURT

On February 24, 1986, the Court accepted review in Gray v. Mississippi (No. 85-5454), 38 Cr. L. Rptr 4185. The Court is asked to decide whether the exclusion of a juror who gave equivocal answers concerning opposition to the death penalty, in violation of Witherspoon v. Illinois, can be ruled harmless error.

On October 6, 1986, the Court granted the State of Arizona's petition for certiorari in Arizona v. Adamson (No. 86-6), 40 Cr. L. Rptr. 4014. Arizona asks the Court to reverse a lower court decision which set aside Adamson's conviction and death sentence on double jeopardy grounds.

On October 14, 1986, certiorari was granted in Booth v. Maryland (No. 84-5080), 40 Cr. L. Rptr 4056. Booth asks whether the use of testimony concerning the impact of the crime on the victim's family during capital sentencing violates the Eighth and Fourteenth Amendments.

On November 3, 1986, the Court granted certiorari in Burger v. Kemp (No. 86-5375), 40 Cr. L. Rptr 4077. The Court will decide whether a jury instruction on "malice and intent" during Burger's capital trial improperly shifted the burden of proof from the state, in violation of Francis v. Franklin. The Court will also determine whether Burger was denied effective assistance of counsel by failure of his counsel to prepare for the sentencing phase of his trial and by conflict of interest.

On November 10, 1986, the Court granted Nevada's petition for review in Sumner v. Shuman (No. 86-246), 40 Cr. L. Rptr. 4077. Sumner asks whether a mandatory death sentence for murder committed by a prisoner serving a life sentence without possibility of parole violates the Eighth and Fourteenth Amendments.

On January 13, 1987, the Court decided Griffith v. Kentucky, 93 L.Ed. 2d 649 (1987), 55 L.W. 4089. The Court ruled that the holding in Batson v. Kentucky, 90 L.Ed. 2d 69 (1986), forbidding prosecutors to exercise peremptory challenges solely on the basis of race, is to be applied retroactively to cases on direct appeal at the time Batson was decided..

On January 27, 1987, the Court decided California v. Brown, \_\_\_ U.S. \_\_\_, 93 L.Ed. 2d 934 (1987). A capital sentencing instruction to juries not to be swayed by "mere sympathy, passion, prejudice or public opinion" does not undermine the defendant's ability to present mitigating evidence, and does not violate the Eighth and Fourteenth Amendments.

On February 23, 1987, certiorari was granted in Thompson v. Oklahoma (No. 86-6169), 40 Cr. L. Rptr. 4175. The Court is to decide whether the execution of a person who was 15 at the time of the offense constitutes cruel and unusual punishment under the Eighth Amendment. The Court will also determine whether the admission at trial of gruesome photographs of the victim denied Thompson's right to a fair hearing on sentencing.

On April 22, 1987, the Court decided Raymond and Ricky Tison v. Arizona, \_\_\_ U.S. \_\_\_, \_\_\_ L.Ed. 2d \_\_\_, 55 L.W. 5596 (1987). The Court held that, although the Tisons did not themselves kill or intend to kill, they displayed a "reckless indifference to human life" which, together with their major participation in the crime, is sufficient to support a judgment of death. Specific "intent to kill" on the part of the defendant need not be present

to impose the death penalty, as was widely interpreted under Enmund v. Florida, 458 U.S. 782 (1982).

On April 22, 1987, McCleskey v. Kemp, \_\_\_ U.S. \_\_\_, \_\_\_ L.Ed.2d \_\_\_ (1987), 47 CCH S.Ct. Bull. 2112 (1987) was decided. Justice Powell, writing for the five person majority, held that while a proven disparity in the imposition of death sentences, reflecting racial bias against black defendants and against those whose victims are white, exists in Georgia and may exist elsewhere, such discrepancies do not violate the Equal Protection Clause of the Fourteenth Amendment. In order to prevail under that Clause, a criminal defendant (unlike an employment discrimination plaintiff, for example) must prove that decisionmakers in his own case acted with discriminatory purpose. The Court also wrote that racial disparities in criminal sentencing do not constitute a major systemic defect, because "any mode for determining guilt or punishment 'has its weaknesses and the potential for misuse,'" and because such imperfections "are an inevitable part of our criminal justice system."

On April 22, 1987, the Court decided Hitchcock v. Dugger, \_\_\_ U.S. \_\_\_, \_\_\_ L.Ed.2d \_\_\_, 47 CCH S.Ct. Bull. B2105 (1987). The Court held that Lockett v. Ohio shall be retroactive in cases where the defendant was disallowed from presenting mitigating factors not enumerated in the statute.

On May 4, 1987, the Court decided Arizona v. Mauro, \_\_\_ U.S. \_\_\_ (1987), \_\_\_ L.Ed.2d \_\_\_ (1987). The Court found that the admission at trial of a taped recording of Mauro's post-arrest conversation with his wife, which followed his assertion of his Miranda rights, to counsel and to remain silent, did not violate the Fifth or Sixth Amendments.
