*/ Fifteen males and one female inmate in this issue appear with a plus sign (+) next to their names. Seven of them (4B, 2W, 1N) are under death sentence in two states, two (1W, 1B) are under death sentence in three states, and the others (2B, 4W, 1N) are serving term sentences previously imposed in other states. All multiple death-sentenced inmates are listed in their respective several state totals, but each is counted as only one inmate in the national total.

This issue of Death Row, U.S.A. includes bracketed names for 108 capital inmates. The brackets indicate that either a new sentence proceeding is pending following a court order, or that a court-ordered reversal of conviction or sentence is not yet final due to an appeal filed by the State.

Thirty-one males and two female inmates in this issue appear with a (#) sign next to their names. These inmates were under the age of eighteen at the time of offense.

IN THE U.S. SUPREME COURT

Yates v. Aiken was decided on January 11, 1988 (98 L.Ed.2d 546). The Court held that its 1985 decision in Franklin v. Francis, 471 U.S. 307 (1985), requiring jury instructions on the state's burden to proven "malice and intent" is retroactive to cases decided before its issuance.

On January 12, the Court decided Lowenfield v. Butler, 98 L.Ed.2d 568. The Court held that the judge at Lowenfield's trial did not unfairly coerce the jury into returning a verdict of death by his insistence that its deadlocked members come to a decision. The court also held that there is no constitutional violation where a death sentence is based on aggravating factors that may merely duplicate an element of the underlying crime.

On November 9, oral arguments were heard in Thompson v. Oklahoma (No. 86-6169) (review granted February 23, 1987), 55 L.W. 3597. The Court will decide whether the execution of those who were juveniles at the time of the offense constitutes cruel and unusual punishment under the Eighth Amendment. The Court will also consider whether the admission at trial of gruesome photographs of the victim denied Thompson's right to a fair hearing on sentencing.

Ross v. Oklahoma (No. 86-5309) (review granted June 22, 1987, 55 L.W. 3876) (to be reargued). Can a trial court's refusal to remove a prospective juror who said that he would automatically vote for the death penalty be ruled harmless error, where the defense was then obligated to use a peremptory strike to challenge the juror?

Satterwhite v. Texas (No. 86-6284) (review granted June 1, 1987), 55 L.W. 3807. Did the admission at trial of testimony by a state-paid psychologist about his examination of the defendant, which occurred without knowledge of defendant's lawyer, violate his Sixth Amendment right to effective assistance of counsel under Estelle v. Smith, 451 U.S. 454 (1981)? The Court will also decide whether such a violation under Smith may be ruled harmless error.

Franklin v. Lynaugh (No. 87-5546) (review granted October 9, 1987, 56 L.W. 3288) (argued March 1, 1988). The Court will decide whether Texas juries must be instructed on the effect of mitigating evidence under that state's sentencing scheme.

Amadeo v. Kemp (No. 87-5277) (review granted October 19, 1987, 56 L.W. 3288) (to be argued March 28, 1988). The question involves whether the post-trial discovery of a covert prosecutorial scheme to intentionally underrepresent blacks and women on grand and petit juries gives cause for relief, where defense counsel failed to object to the jury composition at trial.

Mills v. Maryland (No. 87-5367) (review granted December 7, 56 L.W. 3395) (to be argued March 30, 1988). Johnson v. Mississippi (No. 87-5468) (review granted January 11, 56 L.W. 3459). The Court will decide whether Johnson's death sentence must be overturned where the principal aggravating factor relied upon at trial was a 20 year old out-of-state conviction that has since been invalidated by the New York Court of Appeals.

Maynard v. Cartwright (No. 87-519) (review granted January 11, 56 L.W. 3449). The Court grants Oklahoma's petition for review on the following question: Has Oklahoma interpreted its "[the murder was] heinous, atrocious and cruel" aggravating circumstance in an overly broad manner?

Adams v. Dugger (No. 87-121) (review granted March 7, 56 L.W. 3601). The Court will decide the applicability of Caldwell v. Mississippi, 472 U.S. 320 (1985), which prohibits a prosecutor from suggesting that the responsibility for sentence rests with the appellate court rather than the jury, to Florida, where the final decision as to punishment rests with the trial judge.
