



In that James Wimberly, Jr., did commit Aggravated Rape upon the victim, to wit, a female, Cori LaLonde in that the victim tried to resist the act and the utmost evil was overcome by force by the defendant who used a dangerous weapon.

Court in James Wimberly, Jr. did intentionally engage in a sexual act, to wit, he touched the vagina of another person, to wit, a juvenile, who was not the spouse of the offender where the offender acted without the consent of the victim, and where the victim had not yet attained fifteen years of age and was at least three years younger than the offender, and under circumstances wherein the victim was compelled to submit to the act by being placed in fear of receiving bodily harm.

Court James Wimberly, Jr. being over the age of seventeen, did unlawfully demand a lewd or lascivious act upon the person or in the presence of a child, to wit, a juvenile, under the age of seventeen and there being an age difference of greater than two years between the two persons, done with the intent of arousing or gratifying the sexual desires of either person.
